IMPACT ON PRICING OF THE LENGTH OF THE HARDSTANDING OCCUPANCY PERIOD							
<b>1 - Overstay beyond the authorised occupancy period</b>							
Any overstay on the hardstanding beyond the authorised period will lead to the charge for the entire period of occupancy of the hardstanding being doubled.							
<b>2 - Early vacating of the space occupied</b>							
The charge is due for the entire authorised occupancy period. By way of an exception, the Régie (haul-out service) will bill the actual hardstanding occupancy period, up to a maximum deduction of 3 days from the authorised period.							
<b>3 - Extension of the occupancy period due to unforeseeable circumstances</b>							
If occupancy of the hardstanding has to be prolonged due to unforeseeable circumstances (e.g. weather conditions), the customer will not be charged as long as they <b>do not carry any work</b> during this period.							
<b>4 - Long occupancy periods and low season</b>							
For occupancy periods of 3 weeks or more, authorised by the Régie (haul-out service) and actually completed, companies in the boat building/repair and nautical sectors will be exempted from the occupancy charge for Saturdays, Sundays and public holidays. They will also be granted a 20% discount during the period from 1 October to 31 January.
